School Leaders Report, Jeremiah Newell

- We are expecting between 70-75 Graduates this year
- ACCEL Graduation
 - May 10th deadline for Seniors to complete all work
 - Honor's Night, Baccalaureate Services and the Senior Picnic will be held the week of May 13-19
 - ACCEL Commencement will be held on May 21, 2019 at 6:00pm (Mobile Saenger Theatre)

- Auburn Evaluators will be here to visit the School next week on May 1st and 2nd
- The first inaugural prom for ACCEL Day and Evening Academy will be held this Friday, May 26th at 8:30pm-Heron Lakes Country Club
- The new student application process for next year is going well. We currently have 123 new applications, with over 90 new kids going through the application process. We are expecting approximately 75-80 new kids for next year.
- Great process working with JJPR Marketing.
- Goal for enrollment next year is 325 between day and night classes.
- Charter Legislation-Del Marsh put forth senate bill 311 which provides local funding to charter schools. Will take a small group of students and travel to the State House. We anticipate that the committee will vote on the bill in the following week. The bill will need to pass the Senate and House.
