ACTION ITEM #1- Rob McGinley asked for a motion tom approve the January 28, 2020 BOD minutes.

SchoolWorks Site visit (April 22-23)

 The SchoolWorks Site Visit is a process that educators can use to understand and explain how well schools are working to educate students. More focused on school operation, culture/climate of school, how teachers are supported. Looking for trends in data and provide feedback to school both oral and written to be shared also with Charter Commission. The confirmed date is pending COVID-19 decision. Dr. Miller is leading in pulling documents for pre-visit review.

Climate/Culture- Attendance and Discipline, Nathan Adams

- Trends over three Academic Years
- Discussed monthly attendance. Small decline in attendance. Had to strengthen policies with reaching out to students. Staying within 90% range thanks to the Culture team. Thanks to BOD for providing incentives for kids.
- Discussed Monthly out of School Suspensions. Will provide equity lens of data in April.

Teaching and Learning, Amy Owens

- NWEA Screener- A shortened version of the nationally normed MAP assessment we gave in September and December.
- Purpose of this assessment is to determine progress for students currently enrolled in a Math or English Class. This date does not reflect schoolwide progress for the year.

State Compliance Monitoring & School Improvement Initiatives, Michael Miller

- ACT monitoring took place on March 10, 2020. ACCEL Day and Evening Academy had "No" findings during the monitoring.
